

**City of University Park Municipal Court
Application for Driving Safety Course**

Driving Safety Course is a suspended sentence. On your plea of guilty or no contest, the Judge will defer the finding of guilt until a later date, assess the applicable fees, and order you to complete a Driving Safety Course. If you successfully comply with the terms, your case will be dismissed with no conviction reported on your Driving Record.

Submit the items below on or before your original court date. **Do not enroll in a driving safety course without first obtaining permission from the court. You are only allowed to request DSC for one offense.**

The following items must accompany your signed application:

1. A copy of your valid State of Texas driver's license (not a Commercial Driver's License [CDL]);
2. A copy of current proof of vehicle insurance; and
3. Payment: A money order or cashier's check made payable to the "City of University Park" in the amount of \$144.00 for driving offenses OR \$169.00 for offenses that occurred in a School Zone. Include the citation number(s) on the check or money order to ensure accurate processing.
4. A sign a legal affidavit stating you are in compliance with this condition.

You are **NOT Eligible** to Take a Driving Safety Course to dismiss a ticket if:

- You have completed a driving safety course for ticket dismissal within the past twelve (12) months prior to the date of your citation.
- You hold a Commercial Driver's License
- You were charged with speeding 25 miles or more over the speed limit or in excess of 95mph

I hereby enter a plea of Guilty No Contest (check one) to the violation of

_____ and waive my right to a jury trial. I waive my right to discovery from the State under Art. 39.14 of the Texas Code of Criminal Procedure. I understand that if I successfully complete the terms of the Driving Safety Course order in a timely manner, my case will be dismissed. If I do not successfully complete the terms of the Driving Safety Course order, I will receive a notice to appear in court to show cause why I did not complete the terms of Driving Safety Course as ordered. Furthermore, I understand that if I do not show sufficient cause, the Driving Safety Course order will be revoked and a judgment of guilty entered and may be reported to the Texas Department of Public Safety in accordance with Texas Code of Criminal Procedure, Art. 27.14(c).
